United States of America (USA) Non-Life Insurance Market @Summary, Competitive Analysis and Forecast to 2027

SUMMARY

Non-Life Insurance in the United States industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). KEY HIGHLIGHTS

The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

The US non-life insurance market had total gross written premiums of \$2,170.3 billion in 2022, representing a compound annual growth rate (CAGR) of 6.2% between 2017 and 2022.

The property segment accounted for market's the largest proportion in 2022,

with total gross written premiums of \$807.9 billion, equivalent to 37.2% of the market's overall value.

The performance of the market is forecast to decelerate, with an anticipated CAGR of 4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$2,642.0billion by the end of 2027. The indispensability of certain types of non-life insurance in the US, such as motor insurance, has supported a stable, moderate pace of market growth and is less affected by mark-to-market changes in inflation.
