SUMMARY

Textile Mills in the United States industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2017-21, and forecast to 2026). The textile mills market includes yarns and fabrics. The value of each segment is for consumption, defined as domestic production plus imports minus exports, all valued at manufacturer prices.

The US textile mills market had total revenues of \$79.2 billion in 2021, representing a compound annual rate of change (CARC) of 0% between 2016 and 2021.

The fabric segment was the market's most lucrative in 2021, with total revenues of \$71.5 billion, equivalent to 90.3% of the market's overall value.

The pandemic adversely impacted the textile manufacturers, and it was found that thousands of jobs vanished as factories shuttered and retail stores closed



temporarily. However, with online sales increasing the market flourished.
