The US Fish & Seafood market had total revenues of \$11,836.1 million in 2022, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.

Market consumption volumes declined with a negative CAGR of 0.7% between



2017 and 2022, to reach a total of 1,107.9 million kilograms in 2022.

The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.1% for the five-year period 2022 %li%2027, which is expected to drive the market to a value of \$13,801.1 million by the end of 2027.
