#### SUMMARY

The Asia-Pacific waste management industry had total revenues of \$28,894.1m in 2019, representing a compound annual growth rate (CAGR) of 1% between 2015 and 2019.

Industry consumption volume increased with a CAGR of 2.3% between 2015 and 2019, to reach a total of 502.7 billion tons in 2019.

China is now producing more waste as its middle class grows, and the government is taking an increasingly hard line on pollution.
