SUMMARY

Waste Management in the Netherlands industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). KEY HIGHLIGHTS

The waste management industry consists of all municipal solid waste (MSW) - including non-hazardous waste generated in households, commercial establishments and institutions, and non-hazardous industrial process wastes, agricultural waste and sewage sludge.

The Dutch waste management industry had total revenues of \$0.7bn in 2020, representing a compound annual rate of change (CARC) of -0.5% between 2016 and 2020.

Industry consumption volume increased with a CAGR of 0.6% between 2016 and 2020, to reach a total of 9.2 million tons in 2020.

The growth seen in 2019 and 2020 was associated with China and Southeast Asian countries banning waste imports.
