SUMMARY

Waste Management in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2015-19, and forecast to 2024). The waste management industry consists of all municipal solid waste (MSW) - including non-hazardous waste generated in households, commercial establishments and institutions, and non-hazardous industrial process wastes, agricultural wastes and sewage sludge.

The Scandinavian waste management industry had total revenues of \$2,350.1m in 2019, representing a compound annual growth rate (CAGR) of 5.8% between 2015 and 2019.

Industry consumption volume increased with a CAGR of 4.3% between 2015 and 2019, to reach a total of 16.3 billion tons in 2019.

Sweden's and Norway's population growth, an increase in environmental awareness, rapid industrialization, and a rise in urbanization will foster the growth of the waste management industry.
