The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The waste management industry within the NAFTA countries had a total market value of \$16,428.5 million in 2016. The Mexico was the fastest growing country, with a CAGR of 5.4% over the 2012-16 period.

Within the waste management industry, the US is the leading country among the NAFTA bloc, with market revenues of \$12,755.2 million in 2016. This was followed by Canada and Mexico, with a value of \$2,041.3 and \$1,632.0 million,



respectively.

The US is expected to lead the waste management industry in the NAFTA bloc, with a value of \$13,977.3 million in 2021, followed by Canada and Mexico with expected values of \$2,256.3 and \$2,011.6 million, respectively.
