The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The water utilities industry within the NAFTA countries had a total market value of \$574.6 billion in 2022. The US was the fastest growing country, with a CAGR of 6.5% over the 2018-22 period.

Within the water utilities industry, the US is the leading country among the NAFTA bloc, with market revenues of \$442.9 billion in 2022. This was followed by Canada and Mexico, with a value of \$109.9 and \$21.9 billion, respectively.

The US is expected to lead the water utilities industry in the NAFTA bloc, with a value of \$544.7 billion in 2027, followed by Canada and Mexico with expected values of \$131.5 and \$27.9 billion, respectively.
