Summary

Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The wine industry within the NAFTA countries had a total market value of \$61,593.3 million in 2023. The Mexico was the fastest growing country, with a CAGR of 4.1% over the 2019-23 period.

Within the wine industry, the US is the leading country among the NAFTA bloc, with market revenues of \$48,310.3 million in 2023. This was followed by Canada and Mexico, with a value of \$10,854.8 and \$2,428.2 million, respectively.

The US is expected to lead the wine industry in the NAFTA bloc, with a value of \$55,477.1 million in 2028, followed by Canada and Mexico with expected values of \$12,622.8 and \$3,961.7 million, respectively.
