SUMMARY

The wine market consists of the retail sale of fortified wine, sparkling wine and still wine products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The Dutch wine market had total revenues of \$4,112.2m in 2017, representing a compound annual growth rate (CAGR) of 1.8% between 2013 and 2017.

Market consumption volume increased with a CAGR of 1.2% between 2013 and 2017, to reach a total of 350.2 million liters in 2017.

The Dutch wine market is mature; changing consumer preferences and rising health consciousness affected volume growth during the review period.
