The company is a subsidiary of Zurich Insurance Group Ltd, an insurance company based in Switzerland. Zurich South Africa is headquartered in Johannesburg, South Africa.

The company reported gross written insurance premium of ZAR3,697.9 million during FY2014, a decrease of 9.5% over FY2013. In FY2014, the company's net written insurance premium was ZAR2,974.4 million, a decrease of 7.9% over FY2013.
