# Abstracts

The global eGRC market size is expected to grow from an estimated value of USD 14.9 billion in 2022 to USD 27.1 billion by 2027, at a Compound Annual Growth Rate (CAGR) of 12.6% from 2022 to 2027. Some of the factors that are driving the market growth include an increase in stringent compliance mandates, integration of AI, ML, and blockchain technologies in GRC solutions, and growth in data and security breaches. However, varying structures of regulatory policies are expected to hinder market growth.

Risk management solutions are expected to grow at the highest CAGR during the forecast period. The execution of risk management strategies is very important for SMEs and large organizations. Due to the increasing complexities in business, it is very important for organizations to enable risk management solutions to understand their risk exposure and manage it cost-effectively. Risk management solutions when integrated with advanced machine learning technology prioritize various events and enable users to concentrate on alerts and events. The growth in Risk management solutions is high due to various factors including IT risks, operation risks, financial risks, etc., this is due to increasing incidents of cyber-attacks on enterprises.
