The global flocculant & coagulant market size is estimated to be USD 10.4 billion in 2023 and projected to reach USD 12.5 billion by 2028, at a CAGR of 3.8%.

Implementation of stringent environmental regulations across the globe for wastewater treatment, limited availability and declining freshwater resources, growth in mining and mineral processing are the factors driving the market for flocculants & coagulants.

However, alternative water treatment technologies, high cost related to acquiring and using flocculants and coagulants. Emerging trends towards eco-friendly and biodegradable flocculant and coagulant, and rapid industrialization and urbanization in emerging economies are expected to offer significant growth opportunities to manufacturers.
