Abstracts

The IT asset disposition market is valued at USD 18.4 billion in 2024 and is anticipated to be USD 26.6 billion by 2029, growing at a CAGR of 7.6% from 2024 to 2029. Factors such shift toward energy-efficient products, and early replacement of IT assets with newer versions to keep up with new technologies are likely to drive market growth during the forecast period. With the rapid evolution of technology and constant innovations, assets quickly become outdated and incompatible with new technologies. Hence, there is an increase in the number of non-performing assets on the market, which drives the IT asset disposition market by creating opportunities for the disposal of obsolete assets.

Shift toward energy-efficient products

In recent years, many technological innovations have led to an increase in demand for energy-efficient products. This is due to the rise in energy-intensive economic activities and growing concerns about global warming resulting from emissions due to power generation. Energy-efficient technologies are designed to reduce overall energy usage, which ultimately reduces energy bills. While energy-efficient products may cost more initially, the savings accumulated over time can make them a wise investment.

Moreover, energy-efficient products also have environmental benefits. When less



energy is generated from fossil fuels, it leads to lower greenhouse gas emissions, which helps to mitigate global warming. As a result, many companies are now replacing their existing assets with new energy-efficient products, thereby giving a boost to the IT asset disposition market.

Growing demand for credible disposition solutions due to rising cybercrime

Customers are seeking credible and reliable IT asset disposition solutions that ensures data security. This increased demand is driven by the significant concern for data security, particularly in response to regulatory requirements and the increasing incidence of cybercrimes. One example of such a law is the EU General Data Protection Regulation (GDPR) which is currently the most recent and impactful version of regulatory requirements.
