## **Abstracts**

The global MSS market size is expected to grow from USD 30.6 billion in 2023 to USD 52.9 billion by 2028 at a Compound Annual Growth Rate (CAGR) of 11.5% during the forecast period. The boost in cloud-managed security services drives the demand for MSS to provide a secure cloud environment. For instance, the Saudi government is investing heavily in initiatives to enhance digital skills, including a \$1.2 billion plan to train 100,000 youths in fields like cybersecurity.
