Abbott India Limited is a public listed company and a subsidiary of Abbott Laboratories USA. Abbott India has headquarters in Mumbai, Maharashtra. The company manufactures pharmaceutical drugs and enjoys strong brand equity multiple therapeutic categories such as Women's Health, Gastroenterology, Neurology, Thyroid, Diabetes, Urology, Pain Management, Vitamins, Anti-Infectives & other therapy areas. Abbott India has a state-of-the-art formulation plant at Verna, Goa designed to produce high quality, high volume formulations. The Company also has in-house development and medical teams to undertake product and clinical development.

The Company posted revenues of INR 23.45 bn by the end of FY 2013-14 registering an annual growth rate of above 12%. By 2018 the revenue for Abbott India Limited increased to INR 23.24 bn, registering an annual growth rate of 11.44%.

Abbott India revenues are expected to grow at a CAGR of 8.7% for the next five years and reach INR 51.96 bn by end of FY 2023.
