## **Abstracts**

The key business segments of Aurobindo Pharma are APIs, Formulations, and Packaging, and the company sells over 300 products in over 125 countries. About 35% sales are generated through APIs, and About 65% of the company's revenue is generated from formulations business, of which 63% of formulation sales comes from United States.

During the period of 2013, the company increased its revenue from INR 58.55 bn to INR 164.99 bn. During the same period 2013-2018, the company registered growth rate of 23.02%.

In the FY 2018, 55% of the revenue came from rest of world (RoW), which is expected to grow at a CAGR of 19.5%, while 45% came from US, which is expected to grow at a CAGR of 10.25%.
