The business segments of Divis labs are Active Pharma Ingredients, Nutraceuticals and intermediates. The company exports over 90% of manufactured products to foreign countries and only 8%-10% is consumed in India yearly. The company derives nearly 90% of revenues from developed economies such as Europe and the U.S.

During the period of 2013-2018, the company increased its revenue from INR 25.97 bn to INR 39.49 bn. For the same period, the company has registered an average growth rate of 8.74%.

In 2014 the total revenue of export revenue for Divis Lab was INR 24.02 bn, which increased to INR 34.69 bn in 2018, showing a growth rate of 9.62%. In 2018 the total revenue share of rest of world was 87%.
