The company is engaged in manufacturing and marketing of branded and unbranded generic formulations. Currently, the company consumes most of the APIs manufactured in its facility, and only a fraction is sold to the external consumers. Also, the company is engaged in contract manufacturing of formulations for pharmaceutical majors. For the last fifteen years, Torrent Pharmaceuticals has been manufacturing Insulin for Novo Nordisk Indian operations.

During the period of 2013-2018, the company increased its revenue from INR 32.11 bn to INR 60.2 bn. During the same period, the company registered the annual growth rate of 13.39%

In 2014 the revenue for India market for Torrent pharma was INR 11.61 bn which increased to INR 23.51 bn in 2018, registering an annual growth rate of 19.29%.
