Abstracts

The combination of contract manufacturing and packaging is defined as co-packaging or co-packers. Many copackers are consultant, focused on various type of packaging such as blister packaging, club storage packaging, contract packaging, food packaging, secondary packaging (cardboard cartons, plastic crates). In packaging contract manufacturer provides the services of packaging and labelling for various types of products such as foods, pharmaceuticals, household products, and industrial products. In the packaging contract manufacturing industry, the demand of packaging process has been increasing therefore the bulk of contracts has been assigned to the contract packager for making private label products. Further, the large retailers or warehouse required the contract packager to printing or size packaging, assemble the multi-packs, operates the primary and secondary packaging. The co-packers also supply to the industries such as beverages, dental, nutrition, medical, pharmaceutical, food, cosmetics.

Significant growth in food and pharmaceutical industry and increased automation which reduces the need for manpower are some of the factors propelling the growth of the global packaging contract manufacturing market. Moreover, increasing sustainable packaging in the market owing to increasing use of corrugated boxes is also significantly contributing in the market. Furthermore, advancement in machinery and automation industry is key factors adopted by the market players for boosting the growth of the packaging contract manufacturing market across the globe. However, factors such as growing environmental concerns related to use of plastic in packaging and managing costs involved in the contract packaging are likely to hamper the growth of the global packaging contract manufacturing market. Growing shift towards the use of eco-friendly plastics and raw materials and continuously changing packaging needs of customers are estimated to boost the market in near future.
