Healthcare supply chain management is the regulation of the flow of medical goods and services from manufacturer to patient, it mainly includes hardware and software, the downstream customer mainly includes the manufacture, providers, and distributors. By end-user, this market includes manufacturers (41%), distributors (41%), and providers (41%), of which the manufacturers dominated the global market in 2016.
