Abstracts

The textile industry is one of China's pillar industries, providing materials and products for other industries, creating jobs and bringing huge trade surplus to China. In 2016, the revenue of China's textile industry was CNY 7,330.23 billion, up by 4.1% YOY; completed fixed asset investment was CNY 1,283.87 billion, up by 7.8% YOY.

The industry is currently in face of complexities and uncertainties. Increasing environmental protection costs, labor costs and land costs and numerous international trade barriers all pose pressure on the industry. Nevertheless, with a completed industry chain, huge production capacity and cost advantages, China's textile industry is still expected to grow in the coming years.

In this report, CRI analyzes 44 textile enterprises listed in A-share market in China.

The report is composed of two parts: the first part is enterprise profiles and the second part is the operation status of these enterprises in the recent decade (presently 2006 to 2016, we will update it to the latest as time goes by).

The operation status is demonstrated from the following perspectives: (1) financial indexes, such as earnings per share, book value per share (BPS), sales per share, net cash flow per share, return on net worth and debt to asset ratio; (2) indexes on the income statement, such as revenue, operating profit, net profit and EBIT; (3) indexes on the income statement, such as revenue, operating profit, net profit and EBIT; (4) indexes on the balance sheet, such as liquid asset, fixed asset, current liability, non-current liability, capital reserve and shareholders' equity.
