Abstracts

In 2008, the market size of China's biopharmaceutical industry was about 70 billion Yuan (about 10 billion US Dollars), whose growth rate passed the whole market size of China's medicine market and also above three sub-sectors including chemical medicine materials, chemical medicine dose and traditional Chinese prepared medicines. Under the circumstances of global economic depression, however, China's biopharmaceutical industry shows a good momentum of development.
