Carbonated soft drinks (CSD) represent the second largest volume segment of non-alcoholic drinks, after water, worldwide. Carbon dioxide gas is incorporated into beverages at high pressure, which gives them an effervescent taste. CSD is further classified as colas, lemon, orange, lime and others. The carbonated soft drinks market in Ireland is set to increase by US\$ 226 million from 2021 to 2027, representing a compound annual growth rate (CAGR) of 5.4% during the forecast period.
