Abstracts

Carbonated soft drinks (CSD) represent the second largest volume segment of non-alcoholic drinks, after water, worldwide. Carbon dioxide gas is incorporated into beverages at high pressure, which gives them an effervescent taste. CSD is further classified as colas, lemon, orange, lime and others. According to StrategyHelix, the carbonated soft drinks market in Poland is expected to increase by US\$ 417 million during 2021-2027, expanding at a CAGR of 4.3% during the forecast period.

The report provides up-to-date market size data for period 2017-2020 and forecast to 2027 covering key market aspects like sales value for carbonated soft drinks. The Poland carbonated soft drinks market is segmented on the basis of product, and distribution channel. Based on product, the carbonated soft drinks market in Poland is categorized into colas, non-colas. The colas market is further segmented into regular colas, and low-calorie colas. In 2020, the regular colas segment made up the largest share of revenue generated by the carbonated soft drinks market. Furthermore, the non-colas market has been categorized into lemonade, orange, and others.
