Carbonated soft drinks (CSD) represent the second largest volume segment of non-alcoholic drinks, after water, worldwide. Carbon dioxide gas is incorporated into beverages at high pressure, which gives them an effervescent taste. CSD is further classified as colas, lemon, orange, lime and others. According to a report by StrategyHelix, the carbonated soft drinks market in Slovakia is set to grow at a healthy compound annual growth rate (CAGR) of 2.6% in the next five years.

The report provides up-to-date market size data for period 2017-2020 and forecast to 2027 covering key market aspects like sales value for carbonated soft drinks. The Slovakia carbonated soft drinks market is segmented on the basis of product, and distribution channel. On the basis of product, the carbonated soft drinks market in Slovakia has been segmented into colas, non-colas. Among these, the non-colas segment was accounted for the highest revenue generator in 2020. By distribution channel, the carbonated soft drinks market in Slovakia has been segmented into supermarkets, groceries, online, others.

The colas market is further segmented into regular colas, and low-calorie colas. The regular colas segment captured the largest share of the market in 2020 and is expected to maintain its dominance during the forecast period. Furthermore, the non-colas market has been categorized into lemonade, orange, and others.

The carbonated soft drinks market is dominated by key players, which are The Coca-Cola Company, Kofola CeskoSlovensko a.s., PepsiCo Inc., BUDIS a.s.
