Bottled water is drinking water packaged into plastic or glass bottles. It can further be categorized as sparkling and still water, with or without flavoring. The global bottled water market is poised to grow by US\$ 65,970 million from 2021 to 2027, registering a CAGR of 6.6% during the forecast period, according to StrategyHelix. Increasing awareness among people about consuming safe water, favorable government regulations and market initiatives, premiumization with the growth of fortified and flavored water are expected to boost the market growth in the coming years.
