A study by StrategyHelix indicates that the perfume market in Denmark is anticipated to expand positively at a CAGR of 1.7% during the forecast period (2021-2027). Rising consumer disposable income and improving standards of living, increasing consciousness among male consumers about personal wellness and appearance, increasing product availability and retail outlet are expected to boost the market growth in the coming years.
