## Abstracts

Wine is a fermented beverage produced from grapes and sometimes other fruits. Yeast consumes the sugar in the grapes and converts it to ethanol, carbon dioxide and heat. Wine ABV (alcohol by volume) can range from as low as 5.5% to as much as 23%. According to StrategyHelix, the wine market in Sweden is expected to increase by US\$ 552 million during 2021-2027, expanding at a CAGR of 2.5% during the forecast period. Rise in number of wineries, increase in wine production, growth in disposable personal income levels and a consumer trend in alcoholic beverages toward premium products, such as wine, and away from beer are the key factors driving market growth.

The report provides up-to-date market size data for period 2017-2020 and forecast to 2027 covering key market aspects like sales value for wine. The Sweden wine market is segmented on the basis of product, and distribution channel. Based on product, the wine market in Sweden is categorized into fortified wine, fruit wine, sparkling wine, still wine. In Sweden, the still wine segment made up the largest share of the wine market. On the basis of distribution channel, the wine market in Sweden has been segmented into supermarkets & hypermarkets, food & drink specialists, online retail, others.

The wine market is dominated by key players, which are Altia Oyj, J. Garcia Carrion S.A., Spendrups Bryggeri AB, Treasury Wine Estates Limited, VINEX-SLAVYANTSI AD.
