According to Statistics MRC, the Global Cardiovascular Health Supplements Market is accounted for \$16.4 billion in 2026 and is expected to reach \$38.1 billion by 2034 growing at a CAGR of 11.1% during the forecast period. According to the centers for disease control and prevention (CDC), in 2021, over 695,000 people in the U.S. died from heart disease, recorded as 1 out of every 5 deaths.

Threat:

Side effects

biloba or garlic, can have blood-thinning effects, which may increase the risk of bleeding in individuals taking blood thinners or undergoing surgery. Common synthetic ingredients in cardiovascular supplements include synthetic coenzyme Q10, folic acid, and certain forms of vitamin B. Moreover, manufacturers may use synthetic ingredients to ensure precise formulations and cost-effective production with specific dietary restrictions or preferences, which are driving this segment's growth.

The omega fatty acids segment is expected to have the highest CAGR during the forecast period

The omega fatty acids segment is anticipated to have highest CAGR during the forecast period due to the incorporation of essential fatty acids, particularly omega-3 and omega-6, to promote heart health. These fatty acids play a crucial role in reducing triglyceride levels, lowering blood pressure, and mitigating inflammation within blood vessels, all of which contribute to a healthier cardiovascular system. Additionally, consumers often turn to omega fatty acid supplements as a convenient way to ensure an adequate intake of these essential nutrients, which are boosting this segment's expansion.

Region with largest share:

Asia Pacific commanded the largest market share during the extrapolated period owing to the large and health-conscious population of the region, which exhibits a significant demand for cardiovascular supplements. This region is home to some of the major key players, such as Pharmavite LLC, Nature's Bounty Co., Amway Corporation, and Abbott Laboratories, that contribute to consumer confidence in the safety and efficacy of cardiovascular health supplements. In addition, the market reflects a trend toward clean labels, natural ingredients, and sustainable sourcing, thereby driving this region's expansion.

Region with highest CAGR:

Europe is expected to witness highest CAGR over the projection period, owing to a growing aging population and a proactive approach to preventive healthcare. Governments and healthcare organizations in Europe actively promote public health initiatives, contributing to the rising adoption of preventive measures against cardiovascular diseases. Further, the regulatory landscape, characterized by stringent quality standards and labeling requirements, ensures product safety and transparency for consumers, which are propelling this region's growth.
