Abstracts

According to Stratistics MRC, the Global Cloud Billing Market is accounted for \$8.13 billion in 2017 and is expected to reach \$48.4 billion by 2026 growing at a CAGR of 21.9% during the forecast period. However, time consumption and continuously changing technologies are hampering the market growth.
