According to Statistics MRC, the Global eDiscovery Market is valued at \$6.34 billion in 2015 and is expected to reach \$26.51 billion by 2022 growing at a CAGR of 22.6% from 2015 to 2022. The North American region commanded the largest market share for E-Discovery solution and service providers. This is attributed to high focus on technological innovations, particularly in the developed nations of North America. APAC is expected to be the register highest CAGR due to the presence of immense growth potential in the emerging nations of the region.
