Abstracts

According to Stratistics MRC, the Global Medical Affairs Outsourcing Market is accounted for \$1.40 billion in 2020 and is expected to reach \$4.05 billion by 2028 growing at a CAGR of 14.2% during the forecast period. Rise in the number of medical affairs, advancement of medical education and growing count of orphan therapies are driving the market growth. However, growing costs of clinical trials and drug development are hampering the growth of the market.

Medical writing sector requires expertise to produce and present particulars, and well-structured documents clearly and concisely.

By geography, North America is going to have high growth during the forecast period which can be attributed to the unavailability of medical affairs experts, which is a major challenge, that has encouraged biopharmaceutical and medical device companies based in North America to outsource certain functions to individuals with a high level of



expertise in the domain.


