The Asia Pacific board management software market was valued at US\$ 823.56 million in 2023 and is expected to reach US\$ 1,799.78 million by 2031; it is estimated to register a CAGR of 10.3% from 2023 to 2031.

As board management software helps an organization's board of directors manage their responsibilities regarding strategic planning and performance reviews, its demand is increasing globally. Market players are continuously working on producing more advanced and innovative board management software to cater to the growing demand. A few of the product developments are mentioned below:

In August 2023, BoardPAC announced the launch of its revolutionary AI chat feature QME within its platform. With this introduction, the company will be able to provide board members, company secretaries, and executives with boardroom interactions and enhance the decision-making process.

In June 2023, Azeus Convene announced the release of Convene 7.0, which includes new and improved board portal capabilities designed to increase boardroom efficiency, collaboration, and governance. The goal of the update is to enhance Convene's current core features and advantages while reinventing the meeting experience and enabling better governance. Convene 7.0, which was purposefully created for boards in a variety



of sectors, turns meeting difficulties into useful features.

Such innovations and advancements by market players by adding new features and capabilities to the software are expected to boost the growth of the board management software market during the forecast period.

APAC is witnessing an increase in the adoption of new technologies, which is one of the main factors creating an opportunity for the growth of the board management software market in the region.
