As of the end of 2014, China totally approved XXX indoxacarb registrations (excluding expired ones).

After the product's patent expired, the registrations of indoxacarb formulations soared. As of the end of 2014, there had been XXX registrations of indoxacarb formulations (excluding expired ones). Most of these registrations were for rice and cabbage, for the prevention and control of rice leaf roller and cabbage caterpillar respectively.
