VIETNAM FOOD PROCESSING INDUSTRY

The global food processing industry are valued at over xx billion VND with more than xx enterprises. The global fishery processing market is expected to achieve xx billion USD in 2023 with a CAGR of xx% in the period of 2018 – 2023. The global processed fruits and vegetables market is forecast to achieve xx billion USD in 2022 with a CAGR of xx% in the period of 2018 – 2022.

Regarding the domestic market, in 9M/2019, the processing of dried fish increased by xx% compared to the same period of 2018.
