## **Abstracts**

High levels of pipeline activity are being observed in Scar treatment during 2019. Clinical development activities are being undertaken by more than 15 companies including Abzena Plc, BirchBioMed Inc, Cotinga Pharmaceuticals Inc, Ember Therapeutics Inc, FBM Therapeutics LLC and others.

A Significant contribution to the Scar pipeline is being observed from emerging companies opting for new approaches to clinical development strategy. The early stage and late-stage Scar pipeline included 16 compounds, driven by increasing number of targeted therapies. Progress is being made in accelerating compounds into advanced stages. However, fluctuating trends are being observed in average duration across three phases.

Increased understanding of underlying causes of Scar condition and increased access to investments is encouraging growth of Scar drug pipeline. However, despite high levels of pipeline activity, increasing clinical trial costs and decreasing drug approval rates is requiring companies to focus more on understanding clinical development pipeline compounds.
