#### **EXECUTIVE SUMMARY**

The canned, dried and smoked fish market in Africa was equal to 5.73 billion USD (calculated in retail prices) in 2014. Until 2024, the canned, dried and smoked fish market in Africa is forecast to reach 23.32 billion USD (in retail prices), thus increasing at a CAGR of 12.53% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 18.00% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 7.69 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 9.57% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and increase at a CAGR of 6.80% per annum.

In the last few years, there has been a clear trend in smoked fish consumption. The consumption of smoked salmon in public places (the HoReCa sector, schools, hospitals, etc.) is higher in the last few years. This is due to a number of factors. The smoked fish and salmon, in particular, is able to meet the clients' needs because almost everybody can eat it (it has no known allergies besides the fish-based ones), it has high protein and high omega-3 fat content, it is free of any religious barriers and it is supported by many local authorities for using it in public places like school canteens or hospitals. In fact, most of the major industry players in the US offer help for different public institutions in preparing menus/specific catering, based on their own smoked salmon products.

One of the most significant restraints is expected to be the increasing health-awareness of contemporary consumers worldwide. Although fish is generally considered healthy, the dried, salted, fermented or smoked fish is a processed one, which raises concerns regarding its effect on human health. People are becoming more educated, thus understanding the difference between fresh fish and processed one. As a matter of fact, according to the American Institute for Cancer Research, which is a nonprofit organization, processed fish (including lox) is considered to be in the same category as "processed meat." The processing itself appears to be the main issue when it comes to cancer risk. Therefore, demand for processed fish and seafood in the medium term is projected to be negatively impacted.
