EXECUTIVE SUMMARY

The carbonated soft drinks market in Africa was equal to 6.51 billion USD (calculated in retail prices) in 2014. Until 2024, the drinks market in Africa is forecast to reach 34.05 billion USD (in retail prices), thus increasing at a CAGR of 16.23% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 20.03% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 10.31 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 9.04% per annum. In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 13.50% per annum.

One of the most important trends on the carbonated soft drinks market is linked with the surging demand for healthy and sustainable products. Consumers' preferences have shifted to more natural products with "clean label", including fermented drinks, teas, lower sugar beverages and fortified drinks with health benefit claims. As a result, the major players have been significantly challenged. In order to remain competitive,



they try to reduce their use of sugar and to include fortified carbonated soft drinks, as well as zero-calorie drinks in their portfolio. In addition, the number of people, who are paying attention to labelling is increasing. Thus, companies also need to focus on transparency and simplicity regarding information in order to gain customers' trust.

While in Asia cola remains one of the most popular flavored carbonated soft drinks, there is a growing interest in the combination of carbonated and dairy drinks. In US, the sales of carbonated soft drinks in 2018 picked up, driven by the diet soda segment. When it comes to corporate restructurings, mergers and acquisition deals have been especially popular in recent years. Some of the largest, including Coca-Cola and PepsiCo have been particularly active. For instance, in 2018, PepsiCo completed the acquisition of SodaStream, a producer of machines that carbonate home tap water. Similarly, Coca-Cola participated in numerous merger deals over the past few years, thus diversifying its portfolio.
