## EXECUTIVE SUMMARY

The cigarettes market in Africa was equal to 22.37 billion USD (calculated in retail prices) in 2014. Until 2024, the cigarettes market in Africa is forecast to reach 46.01 billion USD (in retail prices), thus increasing at a CAGR of 6.53% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 8.63% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 22.92 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 4.44% per annum. In the medium term (by 2024), the indicator is forecast to slow down its growth and increase at a CAGR of 4.02% per annum.

One of the most prominent trends on the global cigarettes market is connected with the decrease of smoking rates over the last few years. Although cigarettes remain the largest segment within the tobacco industry, retail volumes have been falling on a global scale. In many countries across the globe, the smoking cigarettes rate has been flat or even declined in recent decades. In both the US and the

UK, consumption of cigarettes has fallen. In comparison, countries such as Andorra, Luxembourg and Belarus are leading in per capita consumption of cigarettes. Another prominent change on the cigarettes market is linked with the growing trend towards the use of e-cigarettes. The major driver behind this trend is the perception that e-cigarettes are a healthier choice than combustible cigarettes. However, regulations in different countries have been influencing differently the development of the category. For example, e-cigarette sales are effectively banned in some countries such as Brazil, Thailand and in some parts of India.

During the last few years there has been an obvious process of consolidation on the overall tobacco market, prompted by declines in traditional cigarette sales. One of the biggest deals was the takeover of Reynolds by British American Tobacco in 2017. Reynolds, on the other hand, completed the acquisition of its US rival Lorillard a year earlier. The combined business of the US and the UK companies is expected to strengthen their presence on markets such as South America, the Middle East and Africa.
