#### **EXECUTIVE SUMMARY**

The processed potatoes market in Africa was equal to 1.43 billion USD (calculated in retail prices) in 2014. Until 2024, the processed potatoes market in Africa is forecast to reach 5.76 billion USD (in retail prices), thus increasing at a CAGR of 12.64% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 17.80% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 1.73 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 10.74% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and increase at a CAGR of 7.95% per annum.

Although potato crisps remain one of the most popular indulgence categories among people, it has been hugely impacted by the ongoing health awareness trend worldwide. With the increasing number of innovative and healthier launches in the entire savory snack category, it has become difficult for potato-based products to compete. In fact, most people have been turning away from potato crisps towards more healthy alternatives such as rice- and lentil-based snacks, popcorn and others. In order to remain relevant, market players have been exploring opportunities in flavor, functionality, and healthy innovations. In fact, during the past few years, there have been more oven-baked crisp in the shelves of the supermarkets.

Following the increasing interest in healthier lifestyle, the attention towards better-foryou chips has been also increasing in the last few years. As a matter of fact, the market has witnessed more companies to use oils which are perceived to be healthier, including olive oil, coconut oil, as well as canola oil and soybean oil, which are highstability oils. When it comes to flavor, younger generations now have more experience with different cultures, which makes them more familiar with the diversity of international flavors and spices.
