EXECUTIVE SUMMARY

The rice market in Africa was equal to 22.62 billion USD (calculated in retail prices) in 2014. Until 2024, the rice market in Africa is forecast to reach 76.78 billion USD (in retail prices), thus increasing at a CAGR of 11.04% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 15.37% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 24.90 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 7.28% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and increase at a CAGR of 5.33% per annum.

The pasta and rice industry is going through a period of major shifts in consumer preferences. In fact, consumers' evolving choice has influenced pasta and rice production and consumption at all stages of the value chain. Now, people are increasingly health-conscious and more interested in functional foods with additional health benefits. So, demand for healthy and "clean label" products is increasingly growing and is one of the leading trends in the global industry. Aspects such as price and taste are no longer the main drivers of choice for consumers. Instead, consumers' behavior has been significantly influenced by the growing importance of health and wellness, sustainability and social responsibility, as well as by the desire for new experiences.

At the same time, however, the per capita consumption of rice in some Asian countries has been decreasing. Although rice is the main staple of the Asian population, its consumption has been decreasing during the last few years. Some of the reasons include the greater purchasing power of the population and the increased access to other foods. Furthermore, diets are also changing with taste and desire for greater convenience, which are also contributing. As a result, local consumers are including more western-style foods in their diets such as bread and pasta and consuming more instant noodles in place of rice-based dishes. Affordability of noodles is another important consideration in the replacement of rice. Despite the fact that people are eating less rice, consumption of premium quality rice has actually been growing in the last few years, which has ultimately increased domestic prices. As a matter of fact, about 90% of the world's rice is consumed in the region, led by China, India and

Indonesia.
