## EXECUTIVE SUMMARY

The cream cheese market in Asia and Pacific was equal to 1.96 billion USD (calculated in retail prices) in 2014. Until 2024, the cheese market in Asia and Pacific is forecast to reach 3.50 billion USD (in retail prices), thus increasing at a CAGR of 5.83% per annum for the period 2019-2024. This is an increase, compared to the growth of about 5.65% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 4.06 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 1.37% per annum.

In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 2.45% per annum.

Most manufacturers are constantly trying to develop new flavors in accordance with the contemporary consumers' tastes. The younger population is more adventurous, seeking new experiences, which determines the present trend towards new and exotic tastes across the cheese category. As a result, currently on the market can be found a wide range of flavored cheese varieties with spicy, bold flavors. According to industry experts, some of the most popular types include cheeses with jalapeño and chile, as well as more traditional herb-flavored cheese with tarragon, chives, parsley and garlic. In addition, there is also a growing interest in international flavors. Cheese, infused with spices and ethnic flavors, which represent well-known cuisines such as Indian and Middle Eastern are especially popular.

Another trend to consider in the dairy industry is the shift in preference towards full-fat dairy. According to industry experts, the segment of full-fat dairy is growing faster than reduced and fat-free alternatives. Some of the drivers include better taste, but also scientific evidences, which demonstrated that full-fat products can be an important part of consumers' diets. Some of the most popular diets, including Keto and Paleo are promoting the increase in consumption of fats. In particular, major product categories

such as natural cheese and cream cheese experienced a positive move in whole-fat volume sales in the US in 2017, increasing at about 0.8% and 1.5%, respectively. The opposite trend was seen in fat-free and middle-fat product sales. Despite the growing interest in whole fat products, there are still dairy categories, among which processed cheese and margarine, which registered a decrease in whole fat volume sales in 2017 at about 4.2% and 4.5%, respectively. At the same time, however, the fat-free processed cheese also saw a decline in volume sales, which was the largest change in dairy amounting to 26%.
