EXECUTIVE SUMMARY

The cold and roasted meat products market in CIS Countries was equal to 8.95 billion USD (calculated in retail prices) in 2014. Until 2024, the cold and roasted meat products market in CIS Countries is forecast to reach 17.66 billion USD (in retail prices), thus increasing at a CAGR of 4.73% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 10.01% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 14.14 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 9.54% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and

increase at a CAGR of 5.42% per annum.

Meat is highly sensitive with regards to changes in consumer preferences. One of the leading trends in the food industry as a whole is linked with the constantly changing eating habits. In recent years, the customers are changing their eating habits and lifestyle more regularly, which is especially obvious in their meat-eating habits.

Consumer preferences are shifting to sustainable and culturally conscious nutrition. As a result, the poultry meat market, in particular, has observed a gradual decrease in meat consumption for food for the last 10 years. At the same time, nearly 50% of consumers in Germany follow a low-meat diet, while 6% of the US consumers were known to be vegans in 2017, compared to just 1% in 2014.

The increasing populations and rising incomes, coupled with the constantly changing diets are one of the main factors driving demand for meat products in the last few years. Individuals all over the world are not only interested in, but also more informed about the link between health and diet. As a result, consumers tend to receive more of their calories from proteins (including meat products) as opposed to basic carbohydrates. There is an increasing number of people who are focusing on body building and muscle strengthening, but are also interested in protein for its long list of health benefits including weight loss, satiety and healthy aging. Furthermore, global issues such as the ageing populations and rising obesity and diabetes levels have further driven consumers towards more healthier choices.
