## EXECUTIVE SUMMARY

The peanut butter market in CIS Countries was equal to 25.00 million USD (calculated in retail prices) in 2014. Until 2024, the peanut butter market in CIS Countries is forecast to reach 96.28 million USD (in retail prices), thus increasing at a CAGR of 10.67% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 18.32% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 0.11 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 16.67% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and increase at a CAGR of 8.94% per annum.

The jams, jellies, chocolate spreads and peanut butter industry is going through a period of major shifts in consumer preferences. In fact, consumers' evolving choice has influenced jams, jellies, chocolate spreads and peanut butter production and consumption at all stages of the value chain. Now, people are increasingly health-conscious and more interested in functional foods with additional health benefits. So, demand for healthy and "clean label" products is increasingly growing and is one of the leading trends in the global industry. Aspects such as price and taste are no longer the main drivers of choice for consumers. Instead, consumers' behavior has been significantly influenced by the growing importance of health and wellness, sustainability and social responsibility, as well as by the desire for new experiences.

Currently, the number of consumers, who are looking for products with no additives or artificial preservatives, is increasing. In fact, the term behind this trend, which is called clean labelling is becoming more popular. Most of the people, nowadays, are aware of clean label claims and these claims influence their buying decisions in regard to jams, jellies, chocolate spreads and peanut butter products. Demand for products with such labelling is increasing and people are inclined to pay a premium price for products with this specific label. In order to respond to the emerging clean label trend, companies within the sector are trying to appeal consumers by reformulating their ingredients and offering preservative-free products. Meanwhile, demand for "free from" products such as gluten free, sugar free, dairy free and more has also increased. When it comes to jams, jellies, chocolate spreads and peanut butter this trend is particularly strong with people looking for more sugar-free or non-GMO products. In addition, consumers have been also actively searching for the following product claims across nut-based spreads and sweet spreads, namely kosher, no additives/preservatives and all natural. Although gluten-free claims have increased in popularity many nut-based spreads and sweet spreads inherently contain no gluten.
