EXECUTIVE SUMMARY

The sausages and salami market in CIS Countries was equal to 9.18 billion USD (calculated in retail prices) in 2014. Until 2024, the sausages and salami market in CIS Countries is forecast to reach 15.80 billion USD (in retail prices), thus increasing at a CAGR of 3.73% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 8.00% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 14.01 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 8.25% per annum.

In the medium term (by 2024), the indicator is forecast to slow down its growth and

increase at a CAGR of 4.72% per annum.

The increasing populations and rising incomes, coupled with the constantly changing diets are one of the main factors driving demand for meat products in the last few years. Individuals all over the world are not only interested in, but also more informed about the link between health and diet. As a result, consumers tend to receive more of their calories from proteins (including meat products) as opposed to basic carbohydrates. There is an increasing number of people who are focusing on body building and muscle strengthening, but are also interested in protein for its long list of health benefits including weight loss, satiety and healthy aging. Furthermore, global issues such as the ageing populations and rising obesity and diabetes levels have further driven consumers towards more healthier choices.

There has been clear move towards premiumization in the industry over the last few years, led by customers' desire to eat less but better. Consumers are increasingly opting for quality, instead of quantity. In the same way, companies have also focused on new product development, offering more innovative premium products with higher quality, rather than focusing on high volumes and low prices. In addition, the number of people, who are paying attention to labelling is increasing. In fact, processed meat products with short ingredients list are considered better. Thus, companies also need to focus on transparency and simplicity regarding information, in order to gain customers' trust.
