The vodka market in CIS Countries was equal to 3.89 billion USD (calculated in retail prices) in 2014. Until 2024, the vodka market in CIS Countries is forecast to reach 4.72 billion USD (in retail prices), thus increasing at a CAGR of 2.88% per annum for the period 2019-2024. This is an increase, compared to the growth of about 1.49% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 9.85 USD per capita

(in retail prices) in 2014. In the next five years, it grew at a CAGR of 3.48% per annum. In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 3.48% per annum.
