## **EXECUTIVE SUMMARY**

The cider, perry & rice wine market in North East Asia was equal to 55.31 billion USD (calculated in retail prices) in 2014. Until 2024, the wine market in North East Asia is forecast to reach 60.19 billion USD (in retail prices), thus increasing at a CAGR of 0.89% per annum for the period 2019-2024. This is an increase, compared to the growth of about 0.66% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 108.15 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 1.29% per annum. In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 1.53% per annum.

The global cider, Perry and rice wine

market has experienced a stable growth over the past few years. The segment is strongly influenced by the growing consumption of low alcohol worldwide, prompted by the changing consumer lifestyle. Market players put more efforts in the development of craft ciders, but at the same time remain focused on provenance and heritage. In addition, consumers interested in healthier lifestyle are more prone to pay premium for ciders with full juice content. Pairing cider with food is another emerging trend, which is likely to change the positioning of the product. Regionally, China and the European region have been leading the market in terms of revenue in recent years. Particularly in Europe, the cider, Perry and rice wine market was one of the fastest growing categories in alcohol beverages. Furthermore, the region held more than half of the worldwide market in terms of consumption, led by the UK. In regards to type, demand for rosé cider is emerging, as well as demand for Japanese rice wines. As a matter of fact, sake in the UK is gaining popularity among sommeliers, as they are looking for something different to offer their clients.
