EXECUTIVE SUMMARY

The cigars market in North East Asia was equal to 222.70 million USD (calculated in retail prices) in 2014. Until 2024, the cigars market in North East Asia is forecast to reach 1.01 billion USD (in retail prices), thus increasing at a CAGR of 8.07% per annum for the period 2019-2024. This is a decrease, compared to the growth of about 27.60% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 0.48 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 6.22% per annum. In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 7.84% per annum.

On contrary to other segments within the

tobacco industry, the cigars and cigarillos category has experienced retail sales growth in both volume and value terms over the last few years. Despite the fact that fewer people are smoking cigarettes nowadays, cigar smoking still remains popular, especially among younger generations. What is more, many of the cigars and cigarillos come in flavoured varieties these days. In order to attract more customers, especially younger ones, most of the companies have been focused on adding flavours to make their products more appealing.

Geographically, the American region is the largest for cigars and cigarillos in terms of retail value. When it comes to flavoured variants, some of the most popular flavours are menthol, cherry and candy. However, in late 2018, the FDA (U.S. Food and Drug Administration) proposed a plan to ban menthol cigarettes and flavoured cigars in the country, mainly due to their appeal to the young people. Another recent development on the market includes the intentions of British tobacco group Imperial Brands to sell its global premium cigar business. Such action is a part of its plan to divest assets worth 2.61 billion USD by May 2020 in order to cut debt and support investments in vaping products.
