#### EXECUTIVE SUMMARY

The rum market in North East Asia was equal to 420.00 million USD (calculated in retail prices) in 2014. Until 2024, the rum market in North East Asia is forecast to reach 350.40 million USD (in retail prices) and decreasing at a CAGR of -1.29% per annum for the period 2019-2024. This is an increase, compared to the decline of about -1.96% per year, registered in 2014-2018.

The average consumption per capita in value terms reached 0.51 USD per capita (in retail prices) in 2014. In the next five years, it grew at a CAGR of 1.32% per annum. In the medium term (by 2024), the indicator is forecast to speed up its growth and increase at a CAGR of 1.36% per annum.

Rum market has been significantly influenced by the modern drink culture in the past few years. Both consumers and bartenders are seriously interested in deepening their knowledge of alcoholic beverages and rum in particular. In addition, provenance, heritage and style are not only describing the dynamic spirit

industry, but also create an emotional appeal and connect with the contemporary consumer. Over the last few years, consumers are increasingly interested in some not so traditional locations for rum production such as Philippines. Similarly, the golden rum is another growing category, prompting the overall rum market across the world. At the same time, as consumers are more willing to try different things, flavored rum is another popular category gaining momentum. Demand for more exotic aromas and unique tastes has stimulated the development and introduction of new taste combinations of fruits and spices such as coffee rum and coconut rum. Premiumization is another strong trend, which is driving the overall market, led by customers' desire to drink less but better. As a matter of fact, the global sales of premium rum, including super-premium and ultra-premium rums have been growing faster than the overall category. Following the growing trend of premiumization, companies are entering into corporate restructuring deals in order to premiumize their portfolios. For instance, in 2019 Diageo announced its agreement with Corporaci?n Cuba Ron to form a joint venture called Ron Santiago. The agreement provides Diageo with an important opportunity to further expand its portfolio in the premium rum category.
